B.4 PRICE

- B.4.1** The cost of services is one of the factors that will be considered in selecting vendors. While the specific services required will vary by project and will be paid based on a scope of work defined by DCPL and pricing negotiated between DCPL and the vendor, we are requesting information that will allow DCPL to evaluate the reasonableness of your fees.
- B.4.2** The following price schedules shall represent the Offeror's compensation for the base and option years. DCPL intends to evaluate the price based on total cost for the base year and option years. Offerors shall submit pricing as fully loaded rates, which include profit and all costs such as direct and indirect costs, overhead and G&A. Failure to include a price for all Contract Line Item Numbers (CLIN) will result in rejection of the proposal.
